

## Announcement of the Ministry

of Finance on the reduction of duty rates and exemption of

customs duties according to Section 12 of the Customs Tariff Emergency B.E. 2530

For the benefit of the country's economy By virtue of Section 12, paragraph one, of the Customs Tariff Emergency Decree, B.E. 2530, the Minister of Finance with approval of the Cabinet issued the following announcement:

๑) Cancel the reduction in duty rates for items under subclass 2204.10.๐๐  
Subcategory 2204.21.11 Subcategory 2204.22.11 Subcategory 2204.29.11

Subcategory 2205.10.10 and subcategory 2205.90.10 according to the list of duty rates at the end of the announcement.
